"KIMMEL CULTURAL CAMPUS – ENTER TO WIN" OFFICIAL RULES

Sponsored by Kimmel Cultural Campus

1. NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.

THE PURCHASE OF ANY GOOD AND/OR SERVICE WILL NOT INCREASE AN ENTRANT'S CHANCE OF WINNING.

VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

- 2. <u>Sponsor</u>. This Sweepstakes (the "Sweepstakes") is sponsored by Kimmel Cultural Campus ("Sponsor"), 300 South Broad Street, Philadelphia, PA 19102.
- 3. <u>Entry Period</u>. The Sweepstakes commences today at the opening of this event and ends at 11:59:59 PM (Philadelphia, Pennsylvania Time) this evening (the "**Sweepstakes Period**"). All entries must be received within the Sweepstakes Period in order to be eligible.
- 4. <u>Sweepstakes Overview</u>. In this Sweepstakes, one (1) Eligible Entry, defined below, will be drawn at random at the close of the Sweepstakes Period, and such drawn Eligible Entry will win a Prize (as herein defined), subject to the other terms and conditions set forth in these Official Rules. By participating in this Sweepstakes, persons submitting entries ("Entrants") agree to be bound by these Official Rules and by the interpretations of these Official Rules by Sponsor, which are final in all matters relating to the Sweepstakes.
- 5. <u>Eligibility</u>. The Sweepstakes is open to any natural person who is a legal resident of the United States of America, including the District of Columbia, and who has reached their 18th birthday prior to the end of the Sweepstakes Period¹ ("Eligible Entrants"). Notwithstanding the foregoing, employees of the Sponsor, its advertising and promotion agencies and affiliated entities (such entities collectively being, "Sweepstakes Entities"), and such employees' immediate families (parent, child, sibling and spouse of any of the foregoing) and persons living in the households of any of the foregoing, whether related by blood or law are not eligible to enter the Sweepstakes and thus are not Eligible Entrants.
- 6. <u>To Enter Sweepstakes</u>. Sponsor is currently running an "Enter to Win Sweepstakes" campaign, designed to encourage individuals to provide email addresses to the Sponsor in order to build a larger consumer data base. Eligible Entrants may enter the Sweepstakes by scanning a Quick Response code (a "**QR Code**"), and providing an email address and

¹ Note to Client: we think this requirement makes sense to include, as in most states, minors (those under eighteen years of age) can disaffirm contracts, which would make it difficult to press certain civil claims on such individuals based on a promotion's Official Rules. Similarly, promotions aimed at "vulnerable" consumers such as children are highly disfavored and, thus, more likely to receive scrutiny from state attorneys general and federal agencies.

contact information where prompted, at any event attended by the Kimmel Cultural Campus, during a Sweepstakes Period.

It is not necessary to scan a QR Code in order to enter the Sweepstakes. A person may enter the Sweepstakes without scanning a QR Code with Sponsor through alternative means herein set forth. Eligible Entrants may enter the Sweepstakes in any one of the following ways:

- a. any individual who provides an email address pursuant to scanning the QR Code during the Sweepstakes Period will be automatically entered;
- b. any Eligible Entrants, who do not scan the QR Code during the Sweepstakes Period may enter by going to Sponsor's website at www.kimmelculturalcampus.org and follow the directions regarding completion the online "Sweepstakes Entry Form" during the Sweepstakes period; and
- c. any Eligible Entrants, including, without limitation, any Eligible Entrants who (i) do not scan the QR Code, or (ii) do not enter by going to the Sponsor's website during the Sweepstakes Period, may nonetheless enter the Sweepstakes through the submission of non-electronic alternative method of entry as herein described (a "Non-Electronic Alternative Entry"). A Non-Electronic Alternative Entry consists of a 3-inch by 5-inch card on which a person has typed or printed legibly the Eligible Entrant's name, address, zip code, telephone number (including area code), e-mail address and date of birth (MM/DD/YYYY). The Non-Electronic Alternative Entry must be completed, and be received by Sponsor at this event before the close of the Sweepstakes Period. Illegible, late, or damaged entries will not be accepted.

Each Eligible Entrant may submit a maximum of 1 (one) entry in the Sweepstakes, which may be submitted manually or automatically in any of the manners set forth above. Each such entry shall be an "Eligible Entry," and collectively, the "Eligible Entries".

- 7. Selection of Sweepstakes Winner. The selection of the winner of the Sweepstakes Prize shall be made by randomly drawing one (1) Eligible Entry from the pool of all Eligible Entries (the "Winner"). The Winner will be selected regardless of age, race, religion, or sexual orientation. In the event an individual whose Eligible Entry has been randomly selected as a Winner in such manner cannot be contacted, does not claim the Prize with forty-eight (48) hours, fails to return the required documents in the required time as provided herein, or refuses or is unable to accept the Prize, another Winner will be randomly drawn from the pool of Eligible Entries until one (1) Prize has been successfully delivered to a Winner.
- 8. Sweepstakes Prize. A total of one (1) Prize will be awarded by Sponsor in the Sweepstakes. The Winner will receive a prize consisting of a ticket or tickets to an event at any of the Sponsor's venues including the Kimmel Center for the Performing Arts, the Academy of Music, or the Merriam Theater (collectively, the "Venues"), ranging in value, not to exceed a value of five hundred dollars (\$500.00) (a "Prize"). No transfers of any Prize is permitted by the Winner. No substitutions of any Prize is permitted,

except as provided for herein. Sponsor reserves the right to substitute any Prize if necessary for any reason. Each Winner is responsible for the reporting and payment of all applicable federal, state and local taxes of the Prize and will hold Sponsor harmless from liability for failure to timely report and/or pay such taxes. There is a limit of one (1) Prize being awarded per individual in the Sweepstakes. The Venues are not participating in or endorsing this Sweepstakes; the Venues are mentioned herein solely for descriptive purposes of the Prize.

The Prize will be delivered electronically to the e-mail address the Winner provided to Sponsor in the Eligible Entry; any upgrades and additional options are at the sole expense of the Winner. Prize specifics to be determined by Sponsor and are subject to availability. SPONSOR DOES NOT MAKE, AND HEREBY EXPRESSLY DISCLAIMS, ANY WARRANTY, REPRESENTATION OR GUARANTEE, EXPRESS OR IMPLIED, IN FACT OR IN LAW, RELATIVE TO THE PRIZE DELIVERED IN THE SWEEPSTAKES INCLUDING BUT NOT LIMITED TO QUALITY, OR FITNESS FOR PURPOSE. Delivery of the Prize is subject to product availability.

- 9. <u>Odds of Winning Sweepstakes</u>. The odds of winning a Prize are dependent upon the number of Eligible Entries received.
- 10. Prize Winner Notification Verification. The Winner will be notified via e-mail or telephone, using the information in Sponsor's records. The Winner will be required to sign affidavits of eligibility, tax acknowledgment forms, liability releases and, if applicable and except where prohibited by law, a use of name and likeness release ("Winner Documents"), and return such Winner Documents to Sponsor within five (5) days of such Winner's receipt. If (a) any prize notification is returned as undeliverable, (b) a Winner declines their Prize, (c) a Winner fails to provide complete entry information and/or timely reply to and/or return all required Winner Documents within the designated time period, (d) a Winner fails to comply with any of the Official Rules as outlined herein, or (e) the Winner fails to claim the Prize within forty-eight (48) hours of the initial contact by Kimmel Cultural Campus, such Winner will be disqualified and an alternate Winner will be selected in accordance with these Official Rules. If an alternative Winner fails to comply with the Official Rules within 30 days after the end of the Sweepstakes Period, Sponsor may donate such Prize, at Sponsor's discretion, to a charity of Sponsor's choice. Sponsor may convert the Prize to cash, at its discretion, and donate the cash to such charity. In the event a Winner has not reached the age of majority in his or her state of residence, Sponsor may require the Winner's parent or legal guardian to execute the Winner Documents on behalf of the Winner.
